The Aggregator Registration Form is specifically for aggregators, as defined by 20 VAC 5-312-10 of the Virginia State Corporation Commission's Rules Governing Retail Access. If an Aggregator offers services beyond the normal aggregation service, then the Aggregator and Company will need to terminate the Aggregator Agreement and complete the Competitive Service Provider application package.

Aggregator access to the Cooperative's Mass List, requires the applicant to execute an Aggregator Agreement, complete the Aggregator Registration Form, and Security Administrator Form. An applicant shall mail the completed information to:
